Space:

The facility is now rated for 300 inmate beds; however, its actual operational capacity is approximately 240 beds. The 2025 rates with respect to average daily count and population on the day of review are lower when compared to 2024 figures. The current average daily count and the population number on the day of review (2025) are some of the lowest figures recorded in the last four years. The agency is working with area stakeholders to manage and reduce the inmate population. The 2025 inmate peak was the highest number recorded in the past three years. In 2023, at one time, the jail was housing approximately 302 inmates. In 2024, at one time, the jail was housing approximately 294 inmates. In 2025, at one time, the jail was housing approximately 312 inmates. At present, the average daily count figure is within the site's operational capacity. At present, the count on the day of the review was also within the site's operational capacity. Historically, the jail has faced space limitations that affect its ability to house inmates properly. At times, the jail can be overcrowded. At times, the jail does not have sufficient room to fully accommodate the jail population. At times, the jail needs more room for special housing and routine duties. In general terms, at the moment, it appears that the population on a typical day is within the site's operating capacity. Recently, the county team slightly modified operations (removed some jail beds), and the building now has 300 jail beds. The jail team found that 300 beds better reflects the site's operational framework. Recently, staff launched new efforts to reduce inmate population rates. Often, the jail team will transfer inmates to other jails. Several arrestees are processed and released, as opposed to being placed in the jail. The site now has new record-keeping systems that contribute to more efficient processes in terms of case management and population activity. The Review Committee commends the county staff with respect to the positive progress and updates regarding population rates and numbers.

Staffing:

The jail administrator is a certified and commissioned full-time law enforcement officer. Three jail employees are full-time certified law enforcement officers, while two others are (specialized) law enforcement officers. The employee files and applicant packets were current, correct, and in good order. A number of employees have recently secured a range of training hours. At present, several employees are completing the jail standards course. At times, the jail leadership team assists other agencies with training resources and support measures. The agency maintains impressive training records and logs. Staff are working to make minor updates to training records. On a typical day, the jail has five vacant employee positions out of 38 total slots, which is a very positive update when compared to the 2024 rate. The Review Committee commends the agency's new strategies for improving employee recruitment and retention. In the past, staffing levels appeared adequate to meet operational demands (in terms of budgeted positions). In both the past and present, when staffing is low (due to vacancy rate), on-duty employees can struggle with hourly goals and daily duties. Previously, it was found that the site was in need of an additional administrative (support) position. At present, jail leadership is working with county leaders to further evaluate and assess the staffing framework and employee system. At times, the jail will have eight to nine employees on duty, and the jail always has at least three employees on duty. Based on current operations and needs, the leadership team is working on options that will ensure eight employees are on duty at all times. In 2026, the jail team will provide an update regarding staffing. Staff, working with county leadership, are exploring options to increase the number of on-duty personnel. In terms of healthcare, a nurse practitioner visits the site once a week, and there are three nurses on duty at various times. Recently, the jail hired a consultant who created and updated new systems and operating platforms. The consultant primarily focused on court-related data entry efforts, interagency coordination and information sharing, internal record keeping, and new protocols for storing archives. These new systems and operating platforms are a positive update and promote success in a variety of areas, including population management and data management. The Review Committee commends the agency for employing a consultant and for additional staffing-related updates.

Population Counts:

On a routine day, the site will usually house approximately:

208 inmates (pretrial felony status)
15 inmates (county ADC bound)
15 inmates (U.S. Marshal Service)
2 inmates (other status)

Almost all inmates are typically housed on felony charges. On occasion, the jail will briefly house misdemeanor inmates.

See Overview / In Progress / Further Development

The Review Team connected the administration team with a national consultant who can assist with staffing analysis and other evaluations. In a coordinated effort, the Review Team and county staff contacted the state health department and the state mechanical inspector to request general walk-through visits. Staff are working to repair and update some phones and kiosks. Efforts are also underway to increase—and in some cases replace—the number of sleeping mats. Staff are updating the camera system, the cell check process, the fire alarm system, and some door fixtures and settings. Updates are also being made to the policy book, cell fixtures, housing components, and fire map.

Building and General Matters

At present, the jail has fewer inmates and more staff (due in part to lower employee vacancy rates) compared to previous times. Over the last year, the county team has invested approximately \$150,000 in site updates, upgrades, and maintenance. The jail kitchen was clean. The site is equipped with AEDs, SCBAs, rules postings, rights postings, and other required items. The Review Committee appreciates the professional staff for the updates and for their service to the community.
